WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Swami Kalyan Dev Vedic College for Management and Education, Vill- Sikkanderpur, Post- Jhijhana, Tehsil- Karana, District- Muzzaffar Nagar, U.P had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **B.Ed** Course of One year duration with an annual intake of 100 (One Hundred only) students on **24.10.2008**.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- AND WHEREAS the matter was placed before the committee in its 146 Meeting held on 05th to 07th August, 2009 and the committee decides to issue Show Cause Notice to the institution. Accordingly Show Cause Notice was issued to the institution on 12.08.2009.
- AND WHEREAS, the applicant institution has submitted its representation to the NRC NCTE on 11.09.2009. The matter was placed before the committee in its 149th Meeting held on 13th to 14th September, 2009 and the committee decides to send VT to verify the facts.
- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- AND WHEREAS the matter was placed before the committee in its 158th Meeting held on 19th to 22nd April 2010 and the committee decides to issue Show Cause Notice to the institution. Accordingly Show Cause Notice was issued to the institution on 10.05.2010.
- AND WHEREAS, the applicant institution submitted its representation to the NRC NCTE, Jaipur on 30.04.2010. The matter was placed before the NRC in its 161st Meeting held on 26th to 29th May, 2010 and the committee observes:
 - The building plan is still not approved by competent authority.

All labs are still ill equipped.

- The library is not properly organized so it is difficult to ascertain the total number of titles.
- Hence, committee decides to refuse recognition to B.Ed. course.
- NOW THEREFORE recognition to Swami Kalyan Dev Vedic College for Management and Education, Vill- Sikkanderpur, Post- Jhijhana, Tehsil- Karana, District- Muzzaffar Nagar, U.P for the course in B.ED in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
