ORDER

Whereas Sant Baba Bhag Singh Memorial Girls College of Education, VPO – Sukhanand, Tehsil – Bagha Purana, Distt. – Moga, Punjab had applied for grant of recognition for **50 seats** in **ETT** course of **two** year duration under section 14(1) of the NCTE Act, 1993 to the NRC, NCTE on 06.03.2007.

And whereas the competent authority had constituted a Visiting Team to visit the institution and the visiting team which visited the institute on **01.07.2008** and submitted its report 09.07.2008.

And whereas in its 130th meeting held on 28th to 31st July, 2008 committee Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, the committee decided to issue 7(9). Accordingly, letter of intent prior to recognition was issued to the institution on 09.08.2008.

The institution did not submit its reply. The matter was again placed before the Northern Regional Committee in its 142nd meeting held on 14th to 16th June, 2009 and the committee decided to refuse the recognition. Accordingly, refusal order was issued on 03.07.2009.

The institution preferred an appeal to the NCTE Hqtrs on 20.07.2009. The Appeal Council accept the appeal and set-aside the NRC' order dt. 03.07.2009 and remand the case to NRC for examination of staff profile, after obtaining the same from the institution and thereafter pass appropriate order in continuation to the earlier order dt. 09.08.2008.

The institution submitted the staff profile on 09.10.2009. The matter was again placed before the Northern Regional Committee in its 150th meeting held on 09th to 11th October, 2009 and the committee decided to issue show cause notice.

The institution submitted its reply to the show cause notice decided by the NRC on 30.11.2009. The matter was again placed before the Northern Regional Committee in its 154th meeting held on 09th to 11th January, 2010 and the committee decided as follows:

- VT may be constituted.

And whereas the competent authority had constituted a Visiting Team to visit the institution and the visiting team visited the institute on **13.05.2010** and submitted its report on 25.05.2010.

And whereas in its 161st meeting held on 26th to 29th May, 2010 the Northern Regional committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, which came to the conclusion that the recognition to the institution be refused for the following reasons :-

- The deficiencies with regard to appointment of Faculty, infrastructure and instructional facilities still exist.


Now therefore grant of recognition to Sant Baba Bhag Singh Memorial Girls College of Education, VPO - Sukhanand, Tehsil - Bagha Purana, Distt. - Moga, Punjab for the course in ETT in terms of section 14(b) of the NCTE Act, 1993, is hereby refused.

Original FDR no. 182605 for Rs. 5.00 lacs drawn by State Bank of India, Branch - Sukhanand is returned herewith.

If the institution is not satisfied by the above Order they can prefer an appeal to the Council in terms of section 18 of NCTE Act, 1993, within 60 days a format for which is enclosed.

Also ordered that a copy of this order to published In the Official Gazette.
