ORDER

Whereas Deepanshu Women's Degree College, Chunnati Gada, Delhi Road, Saharanpur, Uttar Pradesh had submitted an application to the NRC for grant of recognition/permission for conducting BTC Course of two year duration with an annual intake of 50 (Fifty only) on 14.05.2007.

2. And whereas the VT report, the original file of the institution, the NCTE Act Rules, norms & standards of the NCTE were placed before the NRC in 124th meeting. The committee considered the case in detail and noted that the following deficiencies exist vis-à-vis NCTE norms considering the total built up area of all the courses, the built up demarcated area for the proposed BTC course in the institution is less than prescribed in NCTE regulations. The decision of the committee was informed to the institution vide letter dated 03.01.2008. The institution reply was placed in 126th meeting. The committee considered the case in detail and decided that clarification be sought from the institution on the following points:

The institution be directed to submit the details in the MAP and Affidavit as to how it has increased the hall size.

3. The institution reply along with the original file were placed in 140th meeting. The Committee decided to refuse the recognition on the ground that the reply has not been received within stipulated period. The refusal order was issued vide letter dated 12.11.2009. The institution filed Writ petition in the Honorable High Court of Allahabad. As per the direction of the Honorable Court, the matter was placed in 156th NRC meeting and the committee decided to reaffirm the earlier decision as communicated to the institution through letter NRC/NCTE/F-7/UP-2485/140th meeting/ 2009/12248-254 dated 12.11.2009. A corrigendum order was issued on 14.06.2010. The institution filed contempt application. As per the direction of the Allahabad High Court, the matter was again considered by the committee in 162nd NRC meeting and the committee observed the following: the institution has not submitted the modified building plan approved by the competent authority.

- Hence the committee decided to refuse recognition to BTC course of the institution

Now therefore grant of recognition to Deepanshu Women's Degree College, Chunnati Gada, Delhi Road, Saharanpur, Uttar Pradesh for BTC course is hereby refused.

If the institution is not satisfied by the above Order they can prefer an appeal to the Council in terms of section 18 of NCTE Act, 1993, within 60 days.

A copy of the order is to be published in the official Gazette.
