ORDER

Whereas Ch. Suraj Singh Mahavidyalaya, Plot No. 1167, VPO- Jagir, Tehsil- bhongoan, District Mainpuri, Uttar Pradesh had applied for grant of recognition for 25 seats in M.Ed course of one year duration under section 15(1) of the NCTE Act, 1993 to the NRC, NCTE on 15.10.2008.

And whereas the competent authority had constituted a Visiting Team to visit the institution and the visiting team which visited the institute on 28.08.2009 and submitted its report 31.08.2009.

And whereas in its 149th meeting held on 13th to 14th September, 2009 committee Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, the committee decided to issue show cause notice. Accordingly, show cause notice was issued to the institution on 25.09.2009.

And whereas the institution submitted its reply to the show cause notice decided by the NRC on 21.10.2009. The matter was again placed before the Northern Regional Committee in its 154th meeting held on 09th to 11th January, 2010 and the committee decides Re- Inspection of the institution.

And whereas the competent authority had constituted a Visiting Team to visit the institution and the visiting team which visited the institute on 25.03.2010 and submitted its report 29.03.2010.

And whereas in its 159th meeting held on 28th April to 01st May, 2010 Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, the committee decided to issue show cause notice. Accordingly, show cause notice was issued to the institution on 11.05.2010.

The institution submitted its reply to the show cause notice decided by the NRC on 10.06.2010. The matter was again placed before the Northern Regional Committee in its 162rd meeting held on 24th to 27th June, 2010 and the committee decided as follows

The deficiencies communicated to the Institution through letter number NRC / NCTE / UP 3167 / 159 meeting / 2010 / 21786 dated 11 May 2010 still exist.

Hence the committee decides to close the file and return FDRs if submitted.

Now therefore grant of permission to Ch. Suraj Singh Mahavidyalaya, Plot No. 1167, VPO Jagir, Tehsil- bhongoan, District- Mainpuri, Uttar Pradesh for the course in M.Ed in terms of section 15(b) of the NCTE Act, 1993, is hereby refused.
