- AND WHEREAS, the applicant institution has submitted its representation to the NRC NCTE on 28.04.2010. The matter was placed before the NRC in its 161st Meeting held on 26th to 29th May, 2010 and the committee
  - The deficiencies communicated to the Institute through letter number NRC / NCTE / UP-1996 / 157 Meeting / 2010 / 9360 dated 31 March 2010 still exist.
- Hence, the committee decides to refuse recognition of BTC course. 6,
- NOW THEREFORE recognition to B.N. Degree College, Shahabad, District- Hardoi, Uttar Pradesh for the course in ETE in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
