ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 **B.N. Degree College, Shahabad, District- Hardoi, Uttar Pradesh** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **ETE** Course of **two year** duration with an annual intake of **50 (Fifty only)** students on **20.07.2005**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS the matter was placed before the committee in its 121st Meeting held on 07th to 09th September, 2007 and the committee decide to issue Show Cause Notice to the institution. Accordingly Show Cause Notice was issued to the institution on 15.09.2007.

4. AND WHEREAS, the applicant institution has submitted its representation to the NRC NCTE. The matter was placed before the committee in its 157th Meeting held on 24th to 27th March, 2010 and the committee decides to issue Show Cause Notice to the institution. Accordingly Show Cause Notice was issued to the institution on 31.03.2010.

5. AND WHEREAS, the applicant institution has submitted its representation to the NRC NCTE on 28.04.2010. The matter was placed before the NRC in its 161st Meeting held on 26th to 29th May, 2010 and the committee observes:

- The deficiencies communicated to the Institute through letter number NRC / NCTE / UP-1996 / 157 Meeting / 2010 / 9360 dated 31 March 2010 still exist.

6. Hence, the committee decides to refuse recognition of BTC course.

7. NOW THEREFORE recognition to **B.N. Degree College, Shahabad, District- Hardoi, Uttar Pradesh** for the course in **ETE** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

8. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
