ORDER

WHEREAS Khandelwal College of Management Science & Technology, Kalapur, Pilibhit Road, Bareilly, Uttar Pradesh- 243122 had applied for grant of permission for M.ED Course of One year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 09.04.2007.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 126<sup>th</sup> Meeting held on 20<sup>th</sup> to 22<sup>nd</sup> February, 2008, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issued letter of intent prior to recognition under section 7(12) of NCTE Regulations dated 27<sup>th</sup> December, 2005. Accordingly letter of intent prior to recognition was issued to the institution on 26.02.2008

4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The matter was placed before the Committee in its 141<sup>st</sup> Meeting held on 22<sup>nd</sup> to 24<sup>th</sup> May 2009 and the committee observes:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decides to refuse recognition and return FDR's if submitted

6. NOW THEREFORE grant of recognition to Khandelwal College of Management Science & Technology, Kalapur, Pilibhit Road, Bareilly, Uttar Pradesh- 243122 for the course in M.ED in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
