WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Ch. Narender Singh College, Jatoli, Meerut, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting BTC Course of two year duration with an annual intake of 100 (One Hundred only) students on 30.12.2004.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS the matter was placed before the committee in its 109th (2nd Sitting) & 110th Meeting held on 10th November 2006 & 11th to 12th November 2006 and the committee decides to issue clarification letter to the institution. Accordingly clarification letter was issued to the institution on 25.11.2006.
- 4. AND WHEREAS, the applicant institution has not submitted its representation to the NRC NCTE. The matter was placed before the committee in its 124th (1st sitting) Meeting held on 17th to 19th December, 2007 and the committee decided that final intimation letters to be issued before closing the file. Accordingly final show cause notice was issued to the institution on 30.01.2008.
- AND WHEREAS the applicant institution has not submitted its representation to the NRC NCTE, Jaipur. The matter was placed before the NRC in its 140th Meeting held on 25th to 26th April, 2009 and the committee observes that:
 - The reply has not been received within stipulated period. Hence, the committee decides to refuse recognition
- Hence, committee decides to refuse recognition to BTC course. 6.
- NOW THEREFORE recognition to Ch. Narender Singh College, Jatoli, Meerut, Uttar Pradesh for the 7. course in BTC in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993. The FDR of Rs. 5.00 Lakh bearing no. 715447 is returned herewith.
