ORDER

WHEREAS Janta Maha Vidyalaya, VPO- Ajitmal, Tehsil- Auraiya, District- Auraiya, U.P. had applied for grant of permission for B.ED Course of One year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 22.08.2007.

- 2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its **154**th Meeting held on **09**th **to 11**th **January, 2010**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issue **Show Cause Notice** to the applicant institution on **18.01.2010**.
- 4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 04.02.2010. The matter was placed before the committee in its **157**th Meeting held on 24th to 27th March, 2010, and observes:
 - The deficiencies communicated to the Institution through letter F.No./NRC/NCTE /UP-2590/154th meeting/ 2009 / 15137 dated 18 January 2010 still exist.
- 5. AND WHEREAS the committee decides to refuse recognition for B.Ed. course.
- 6. NOW THEREFORE grant of permission to **Janta Maha Vidyalaya**, **VPO- Ajitmal**, **Tehsil- Auraiya**, **District- Auraiya**, **U.P.** for the course in **B.ED** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
- 7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
