The original file of the institution as well as other documents and materials submitted by the institution were duly considered by the NRC in its 157th Meeting held on 24th to 27th March, 2010, and decides:
 - The deficiencies in respect of common room and toilets for girls still exist.
- 5. AND WHEREAS the committee decides to refuse recognition for B.Ed. course.
- 6. NOW THEREFORE grant of recognition to **Shree Ram Institute of Education, Vill- Timakiya, Post- Jami Khurd, Tehsil- Meerut, District- Meerut, U.P.** for the course in **B.ED** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
