- AND WHEREAS the matter was considered by the committee in its 157th meeting held on 24th to 27th 4. March, 2010 and the committee observes the following:

- AND WHEREAS the following was the ground of refusal was: 5.
 - The Professor has not been selected through dully constituted selection committee as per NCTE norms for M.Ed.
- NOW THEREFORE grant of recognition to H.L.M. College, KL-114, VPO- Ghaziabad, Tehsil + District-Ghaziabad, Uttar Pradesh for the course in M.ED in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993. By Order
