ORDER

WHEREAS **Oxford Model Institute of Advance Studies, PAC Road, Shyam Nagar, Kanpur, Uttar Pradesh** was granted recognition for B.ED Course of One year duration from the academic session 2008-2009 by the Northern Regional Committee, NCTE vide order no. F.NRC/NCTE/F-7/UP-2129/2008/56380-86 dated 18.08.2008.

2. The said institution filed a writ petition no. 8398/2010 in the Hon'ble High Court of Allahabad, Uttar Pradesh for quashing of the order dated 18th August 2008 passed by the Northern Regional Committee of the National Council for Teacher Education to the extent that the recognition for conducting B.Ed Course of one year with annual intake of 100 students should be for the academic session 2007-2008 instead of 2008-2009. The petitioners have also sought the quashing of the order dated 23rd April, 2009 by which the Appeal filed by the petitioners under Section 18 of the National Council for Teacher Education, Act 1993 (hereinafter referred to as the 'Act') has been rejected on the ground of delay.

3. In this connection the Order passed by the Hon'ble High Court of Allahabad, Uttar Pradesh was placed before the Northern Regional Committee in its 157th meeting held on 24th to 27th March, 2010. The Committee observes as follows:-

- **As per the order of Hon'ble High Court of Allahabad, Allahabad, the case was considered by the committee and decided that its' order dated 18 August 2008 stands as it is.**

4. NOW THEREFORE grant of recognition to **Oxford Model Institute of Advance Studies, PAC Road, Shyam Nagar, Kanpur, Uttar Pradesh** for the course in B.Ed in term of section 14(3)(b) of the NCTE Act, 1993 stands as it is.


