WHEREAS Lakshmi Narayan Mahavidyalaya, Plot No. 798 & 950, Vill- Mau, Post- Kaithawali, Tehsil- Sadar, District- Mau, U.P. had applied for grant of recognition for B.ED Course of One year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 27.10.2008.

- 2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 149<sup>th</sup> Meeting held on 13<sup>th</sup> to 14<sup>th</sup> September, 2009 the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issue **Show Cause Notice** to the applicant institution on 25.09.2009.
- 4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 13.10.2009. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 151<sup>st</sup> Meeting held on 20<sup>th</sup> to 21<sup>st</sup> October, 2009 the committee decides decided to issue letter under clause 7(9) of Regulations 2007. Accordingly letter was issued to the applicant institution on 04.12.2009.
- 5. AND WHEREAS the applicant institution has submitted the representation to the NRC NCTE, Jaipur on 23.12.2009. The original file of the institution as well as other documents and materials submitted by the institution were duly considered by the NRC in its **154**<sup>th</sup> Meeting held on **09**<sup>th</sup> **to 11**<sup>th</sup> **January, 2010** the committee directs the college to appoint HOD and Faculty as per NCTE norms for B.Ed and submit the required documents. Accordingly a letter was issued to the institution on 18.01.2010
- 6. AND WHEREAS the applicant institution has not submitted the representation to Northern Regional Committee, NCTE. The matter was placed before the committee in its 157<sup>th</sup> Meeting held on 24<sup>th</sup> to 27<sup>th</sup> March, 2010, and observes:
  - The Institution has not replied letter F.NO./ NRC/ NCTE/ UP-3272/ 154 meeting/
- AND WHEREAS the committee decided to close the file.
- 8. NOW THEREFORE grant of recognition to Lakshmi Narayan Mahavidyalaya, Plot No. 798 & 950, Vill- Mau, Post- Kaithawali, Tehsil- Sadar, District- Mau, U.P. for the course in B.ED in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
