Corrigendum to order no. F.NRC/NCTE/F-7/UP-2485/156 Meeting/2010 /18625-18621 dated 16,03,2010.

WHEREAS Deepanshu Women's Degree College, Chunnati Gada, Delhi Road, Distt. - Saharanpur, Uttar Pradesh - 247001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting BTC. - AND WHEREAS, the original file of the institution, reply of the Institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 140th meeting held on 25th - 26th April, 2009 and the committee decided to refuse recognition to the institution. Accordingly refusal order was issued to the institution on 12.11.2009.
- The said institution filed a writ petition 62828/2009 in the Hon'ble High Court of Allahabad. As per the Court direction the matter was placed before the NRC in its 156th Meeting held on 23rd - 24th February, 2010 and

As per direction of Hon'ble High Court of Allahabad, Allahabad, the case was reconsidered and the committee reaffirmed the earlier decision as communicated to the Institution through letter NRC / NCTE / F-7 / UP-2485 / 140th meeting / 2009 / 12248-254 dated 12 November 2009.

- AND WHEREAS the committee decides to reaffirmed the earlier decision as communicated to the institution, therefore grant recognition to Deepanshu Women's Degree College, Chunnati Gada, Delhi Road, Distt. - Saharanpur, Uttar Pradesh - 247001 for the B.T.C. Course is hereby refused.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
