Whereas Baba Kundan Rural College of Education, Vill - Kulliwail, Jamalpur, Distt. - Ludhiana, Punjab - 141001 had applied for grant of permission for 50 seats in D.Ed. course of two year duration under section 15(1) of the NCTE Act, 1993 to the NRC, NCTE on 24.03.2008.

And whereas a show cause notice u/s 15 dated 15.04.2010 was issued to the institution.

The institution submitted its reply on 12.07.2010. Upon consideration of the report submitted by the visiting team, perusal of videography and other materials furnished by the institution along with the application, the Northern Regional Committee in its Emergent meeting held on 19th July, 2010, the committee decides as follows:

- The deficiencies communicated to the Institute through letter NRC/NCTE/PB-628/157 meeting/2010/ 20361 dated 15 April 2010 still exist.

Hence the committee decides to refuse recognition and return FDRs if submitted.

Now, therefore grant of permission to Baba Kundan Rural College of Education, Vill - Kulliwail, Jamalpur, Distt. - Ludhiana, Punjab - 141001 for the course in D.Ed. in terms of section 15(3)(b) of the NCTE Act, 1993, is hereby refused.

Original FDR no. 144620 for Rs. 5.00 lakh & FDR no. 144593 of Rs. 3.00 lakh drawn by Punjab & Sindh Bank is returned herewith.

If the institution is not satisfied by the above Order they can prefer an appeal to the Council in terms of section 18 of NCTE Act, 1993, within 60 days a format for which is enclosed.

Also ordered that a copy of this order to published in the Official Gazette.
