ORDER

WHEREAS, VIVEKANAND COLLEGE OF EDUCATION VPO- BAWWA, DISTT- REWARI, HARYANA-123303 was granted recognition for running D. Ed. Course of Two years duration with an annual intake of 50 students vide this office order number F/NRC/NCTE/F-3/HR-1283/2008/57414-57420 dated 19.08.2008

AND WHEREAS, the original file of the institution along with all other related documents, Act of NCTE 1993 Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 161st meeting held from 26th to 29th May, 2010 and the Committee observes the following:-

- Submitted building plan does not indicate khasra number.
- Building plan is not approved by competent authority.
- All labs are ill equipped.
- Faculty for B.Ed. and D.Ed. has not been appointed through duly constituted committee.

Hence, the committee decides to withdraw recognition of D. Ed. course from academic session 2010 - 2011.

AND WHEREAS the recognition of the institution was withdrawn vide this office order no. NRC/NCTE/F-3/HR-1283/2010/23883-23890 dated 21.06.2010.

AND WHEREAS the institution preferred an appeal to the Appellate Authority against the NRC order dated 21.06.2010 and the council after perusal of documents, memorandum of appeal, affidavit and after considering oral arguments advanced during the hearing and the Court directions, the Council reached the conclusion that there was adequate ground to accept the appeal and reverse NRC's order dated 21.06.2010 with direction to the NRC to restore recognition of the institution with immediate effect.

NOW THEREFORE the recognition to VIVEKANAND COLLEGE OF EDUCATION VPO- BAWWA, DISTT- REWARI, HARYANA-123303 for D. Ed. course is hereby restored.
