WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 District Institute of Education and Training, Etawah, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition for starting BTC of two year duration with an annual intake of 50 (Fifty only) students on 08.01.2005.

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 132^{nd} NRC Meeting held on 11^{th} to 14th September, 2008, the committee decided to issue a letter of Intent Prior to Recognition to the institution. Accordingly letter was issued to the institution vide letter no. F.No. /NRC/NOTE/UP-1971/2008/63211-63212 dated 23.09.2008.
- AND WHEREAS, the applicant institution has submitted a representation to the NRC NCTE, Jaipur on 19.11.2008. After examining the representation it was found that some conditions/ requirements have not been fulfilled. Accordingly a clarification letter was issued to the institution vide letter no. F.NRC/NCTE/F-7/UP-1971/2006/67692 dated 30.12.2008.
- AND WHEREAS, the applicant institution has submitted a representation to the NRC NCTE, Jaipur on 28.01.2009. The original file of the institution along with the representation submitted by the institution was considered in the 137th Meeting of NRC held on 28th February to 1st march, 2009 and the committee decided to issue clarification letter to the institution. Accordingly letter was issued to the institution vide letter no. F.NRC/NCTE/F-7/UP-1971/2009/71134 dated 12.03.2009.
- AND WHEREAS, the applicant institution had not submitted the representation to the NRC NCTE, Jaipur. The matter was placed before the Committee in its 149th NRC Meeting held on 13th to 14th September, 2009 and committee decided to refuse the recognition to BTC course. Accordingly refusal order was issued to the institution on08.12.2009. The above said institution, thereafter preferred an appeal dated 21.01.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, VT Report, affidavit and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was enough ground to accept the appeal and that it should be accepted. Accordingly the appeal was accepted and NRC order dated 08.12.2009, was reversed with a direction to the NRC to issue formal recognition order.
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to District Institute of Education and Training, Etawah, U.P. for conducting BTC course of Elementary (Level) of two year duration with an annual intake of 50 Students (Fifty only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:
 - I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
 - II. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
