#### ORDER

WHEREAS in terms of Section <u>15(1)</u> of the NCTE Act, 1993 V.K. Jain College of Education, Soron Road, Kasganj, Etah- 207001, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting <u>BTC</u> Course of Two year duration with an annual intake of 50 (Fifty Only) students on 02.04.2004.

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 104<sup>th</sup> Meeting of NRC, the committee noted that the following compliance required to be made by the institution before the commencement of the academic session 200-2007. 1.) Appoint duly selected staff with the requisite qualification as per NCTE Norms and Standards and inform the Regional Committee.

  2.) Affidavit of Rs. 100/- stamp paper to be submitted as per para 8(b) of the NCTE Regulations dated 13.01.206. Accordingly letter was issued to the institution vide letter no. F.No.NRC/NCTE/F-7/UP-1567/2006/512 -31 dated 26.08.2006. The applicant institution has submitted representation to Northern Regional Committee on 08.09.2006. A clarification letter was issued to the institution vide order no. F.NRC/NCTE/F-7/UP-1567/2006/8134 dated 06.02.2008.
- 3. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE, Jaipur on 27.11.2006 and the matter was placed before NRC in its 141<sup>st</sup> Meeting held on 22<sup>nd</sup> to 24<sup>th</sup> May 2009 and the committee decided to refuse the recognition for BTC Course of Two year duration. Accordingly order was issued vide order no. F.NRC/NCTE/F7/UP-1567/141 MEETING/2009/5994-6000 dated 09.07.2009. The above said institution, thereafter preferred an appeal dated 20.07.2009 to the NCTE, New Delhi under section 18 of the NCTE Act 1993 against the aforesaid order.
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, set aside NRC's order dated 09.07.2009, and remand back the case to NRC for examination of the staff profile so as to ensure that they have been appointed as pesr NCTE Norms and thereafter pass appropriate order, in its order no. **F.NO. 89-701/2009 -Appeal dated 11.09.2009.**
- 5. AND WHEREAS the matter was placed before the committee in its  $153^{rd}$  Meeting held on  $11^{th}$  to  $12^{th}$  December, 2009 and the committee decided to grant recognition under clause 7(11) of Regulations 2007.
- 6. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to V.K. Jain College of Education, Soron Road, Kasganj, Etah-207001, U.P. for conducting BTC Course of Elementary (Level) of Two year duration with an annual intake of 50 Students (Fifty only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:
- 7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- C. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc,
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes a, / of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always 13. display following as mandatory disclosure: -
  - Copy of the Application Form
  - Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
