WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Jai Narayan Smarak Degree College, Sehra, Karchhana, Allahabad- 212301, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition for starting **B.Ed** of **One year** duration with an annual intake of **100 (One** Hundred only) students on 30.09.2005.

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its  $109^{th}$  ( $2^{nd}$  Sitting) &  $110^{th}$  Meeting held on  $10^{th}$  November 2006 &  $11^{th}$   $12^{th}$  November 2006, the committee decided that Recognition be granted to the B.Ed course of one year duration with an annual intake of 100 (One Hundred only) w.e.f. the academic session 2006-2007 subject to the condition of submission of the list of appointed qualified staff by following the selection procedure before the commencement of the course. Accordingly order was issued to the institution vide letter no. F.NRC/NCTE/F-7/8314-8339 dated 14.11.2006 & Letter No. F.NRC/NCTE/F-7/UP-2001/21276 dated 09.07.2007.
- AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE, Jaipur. The matter was placed before the Committee in its 141st NRC Meeting held on 22nd to 24th May 2009 and the Committee decided to refuse recognition and return the FDR's if submitted. Accordingly refusal order was issued to the Institution vide order no. F.NRC/NCTE/F-7/UP-2001/141 Meeting/2009/5885-5891 dated 09.07.2009. The above said institution, thereafter preferred an appeal dated 20.08.2009 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after hearing oral arguments advanced during the hearing, the Council reached the conclusion that there was no ground to accept the appeal and that should be rejected. Accordingly, the appeal was rejected and NRC's order dated 09.07.2009 was confirmed. The Above said institution, thereafter filed a writ petition challenging the impugned order dated 09.07.2009 and 08.10.2009 passed by the NRC, Jaipur of the NCTE and also the NCTE which is appellate authority respectively. The matter was placed before the committee in its 153rd Meeting held on 11th to 12th December, 2009 and the committee decide as per the decision of Hon'ble High Court Allahabad, the case is being sent to Appellate Authority along with the relevant documents for necessary action. Accordingly file was sent to the NCTE Hatrs and as per the direction of the appeal, after perusal of documents, memorandum of appeal affidavit, VT report and after hearing oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal and set aside NRC's order dated 09.07.2009 with direction to the NRC to grant formal recognition to the institution.
- NÓW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Jai Narayan Smarak Degree College, Sehra, Karchhana, Allahabad- 212301, U.P. for conducting B.Ed course of Secondary (Level) of One year duration with an annual intake of 100 Students (One Hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:
  - The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
  - II. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
