WHEREAS in terms of Section <u>15(1)</u> of the NCTE Act, **Dr. Ram Manohar Lohia Degree College, Khasra No. - 196, 240, 280, 633, 644, 419, 420, Vill - Jhotari, Post - Dhamupur, Tehsil - Jakhanian, Distt. - Ghazipur, Uttar Pradesh,** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting <u>B.P.Ed</u> Course of <u>one year</u> duration with an annual intake of **50 (Fifty only)** students on **30.10.2008**.

- 2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **Secondary PE Teacher Education Programme** such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the Programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Dr. Ram Manohar Lohia Degree College, Khasra No. 196, 240, 280, 633, 644, 419, 420, Vill Jhotari, Post Dhamupur, Tehsil Jakhanian, Distt. Ghazipur, Uttar Pradesh for conducting 3.P.Ed of Secondary PE (level) of one year duration with an annual intake of 50 (Fifty Only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:
 - I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
 - II. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.
- 4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- 5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.
- In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
