**ORDER** 

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Sarvodaya Mahavidyalaya, Chaumuhan-281406, Mathura, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting **B.Ed** Additional Intake of One year duration with an annual intake of 40 (Forty only) students on 06.02.2007.

- AND WHEREAS the Letter of Intent was issued to the institution vide office letter no. F.NRC/NCTE/F-7/UP-2350/2007/31895 dated 02.11.2007.
- AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE, Jaipur on 18.12,2007. After examining the representation of the institution found that some essential documents were not submitted by the institution. Hence a clarification letter was issued to the institution on 17.01.2008.
- AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE, Jaipur. The matter was placed before the Committee in its 140th NRC Meeting held on 25th to 26th April, 2009 and the Committee decided to close the file and return FDR's if submitted. Accordingly closed order was issued to the institution vide order no. F.NRC/NCTE/F-7/UP-2350/140 Meeting/2009/6738 dated 24.07.2009. The above said institution, thereafter preferred an appeal dated 18.09.2009 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report affidavit and afer considering oral arguments advanced during the hearing, the Council reached the conclusion that there was enough ground to accept the appeal and that it should be accepted. Accordingly, the appeal was accepted and NRC's order dated 24.07.2009 was reversed, with a direction to the NRC to issue a recognition order basic unit of 100 students, by enhancing the existing of 60 students by 40 more students vide its order no. F.NO. 89-1084/2009 - APPEAL dated 06.11,2009.
- NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Sarvodaya Mahavidyalaya, Chaumuhan- 281406, Mathura, U.P. for conducting B.Ed Additional Intake of Secondary (Level) of One year duration with an annual intake of 100 (60 Existing + 40= 100) Students (One Hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:
  - I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
  - II. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
  - Copy of the Application Form
  - Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.
- In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to g et the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
