

WHEREAS in terms of Section <u>15(1)</u> of the NCTE Act, 1993 Shri Shivdan Singh Smriti College, Vill - Iglas, Distt. - Aligarh, U.P. had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting B.P.Ed of One year duration with an annual intake of 50 (Fifty only) students on 31.12.2004.

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 109^{th} meeting held on 10^{th} to 12^{th} November, 2009, the committee decided to issue a Show Cause Notice to the institution. Accordingly Show Cause Notice was issued to the institution vide letter no. F.NRC/NCTE/F-3/UP-1770/2006/8902 dated 25.11.2006.
- 3. AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE Jaipur on 26.12.2006. The matter was placed before the Committee in its 112^{th} NRC Meeting held on 27^{th} to 28^{th} December, 2009 and the Committee decided that recognition be granted to the B.P.Ed. course of one year duration with an annual intake of 50 (Fifty Only) (One Unit) w.e.f. the academic session 2006-2007 subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE / State Govt. / Affiliating university given effect before the commencement of the course. Accordingly order was issued to the institution on 29.12.2006. The institution has not been submitted its reply and a letter was issued to the institution regarding compliance of the order dated 29.12.2006. The institution submitted its reply on 05.10.2007. After consideration of the reply submitted by the institution a letter regarding compliance to the conditional recognition order was issued on 06.02.2008. The institution has not been submitted its reply. The matter was placed before the NRC in its 141 Meeting held on 22 - 24 May, 2009. The committee observes following:
 - The list of appointed faculty as per NCTE norms has not been submitted till date.
- Hence, the committee decides to^{\prime} refuse recognition and return FDRs if submitted. Accordingly refusal order was issued to the institution vide this officer order no. F.NRC/NCTE/F73/UP-1770/141 MEETING / 2009 / 10713-10719 dated 25.09.2009. The above said institution, thereafter preferred an appeal dated 10.11.2009 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal and it should be accepted. Accordingly the appeal was accepted and NRC's order dated 25.09.2009 was reversed with a direction to the NRC to issue formal recognition order under clause 7(11) of NCTE Regulations within 15 days of issue of this order vide its order no. F.NO. 89-1318/2009 -APPEAL dated 12.02.2010.
- NOW, THEREFORE, In exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Shri Shivdan Singh Smriti College, Vill - Iglas, Distt. - Aligarh, U.P. for conducting <u>B.P.Ed</u> course of Secondary Physical Education (<u>Level</u>) of One year duration with an annual intake of 50 Students (Fifty only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:
 - The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
 - III. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating

- 7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional.
- 8. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 9. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- 10. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- 11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- 12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- 13. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- 13. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution falling to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to g et the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
