WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Jhambaba Degree College, VPO-Su-gupur, Ambedkar Jagar, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting B.P.Ed Course of One year duration with an annual intake of 50 (Fifty Only) students on 06.12.2004.

- 2. AND WHEREAS the original me of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 109th Meeting held on 31st October, 2006 to 1st November, 2006 the committee decided that Recognition be granter of the B.P.ED Course of one year duration with an annual intake of 50 (Fifty Only) w.e.f. the academic session 2006-2007 subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt/Affiliating University given effect before the commencement of the course and accordingly letter was issued vide NCTE letter no. F.NPC/NC E/F-3/UP-1614/2006/7893-7902 Dated 09.11.2006.
- 3. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, ECTE, Jaipur and the matter was placed before NRC in its 141st Meeting held on 22nd to 24th is av 2009 and the committee decided to refuse the recognition for B.P.ED Course of one year duration. Accordingly order was issued vide order no. F.NRC/NCTE/F7/UP-1614/141 MEETING/2009/5892-5898 dated 09.07/2009. The above said institution, thereafter preferred an appeal dated 03.08.2009 to the NCTE, New Delta under section 18 of the NCTE act 1993 against the aforesaid order.
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was dequate ground to accept the appeal, set aside NRC's order dated 09.07.2009, for issuing a show cause notice, __fc_ passing a final order, in its order no. **F.NO. 89-786/2009 -Appeal dated 08.10.2009.**
- 5. AND WHEREAS the maker was placed before the NRC NCTE in its 151st Meeting held on 20th to 21st October 2009 and the committee decided process the file as directed. Accordingly show cause letter was issued to the institution, vide order no. **F.NRC/NCTE/F-3/UP-1614/Appeal/2009/12476 dated 18.11.2009**. The applicant institution has submitted the representation to Northern Regional Committee, NCTE, Jaipur and the maker was placed before the NRC in its 153rd meeting held on 11th to 12th December, 2009 and the committee decided to grant recognition under clause 7(11) of regulation 2007.
- 6. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Jhambaba Degree College, VPO-Surjupur, Ambedkar Nagar, U.P. for conducting B.P.Ed Course of Secondary Physical (Level) of One year duration with an appear intake of 50 Students (Fifty only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of le following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) caree J1/10/2009:
- 7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- 8. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- 9. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- 10. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- 11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- 12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- 13. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - · Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.

14. e if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
