ORDER

1. WHEREAS, the R.K.S.D. College of Education Kaitthal, Ambala Road Kaitthal, Haryana was granted recognition for running B.Ed. Add. Course of One year duration with an annual intake of 100 students vide this office order no. F.NRC/NCTE/F-7/HR-944/2007/30311-30317 dated 12.10.2007.

2. AND WHEREAS, the show cause notice under section 17 of NCTE Act was issued on 04.11.2009 with a direction to submit reply within 21 days.

3. AND WHEREAS, The original file of the Institution, reply of the Institution along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 161st meeting held from 26th to 29th May, 2010 and the Committee observes the following:

- For an intake of 200 B.Ed. students, only ten Faculty members have been appointed which is not as per NCTE norms B.Ed.
- Regular Principal has not been appointed.
- Ten computers are not sufficient for an intake of 200 B.Ed students.
- The classrooms are still small in size.
- All labs are still ill equipped.

Hence, the committee decides to withdraw recognition of B.Ed programme for an intake of 200 students from 2010 - 2011 academic session. Accordingly the withdrawal order was issued on 22.06.2010.


4. AND WHEREAS the institution preferred an appeal against the said order and after perusal of documents, memorandum of appeal affidavit VT report and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal, set aside NRC's order dated 23.06.2010 and remand back the case to NRC with direction to continue recognition for the initial intake of 100 students and withdraw recognition for the additional intake of 100 students vide order dated 13.08.2010.

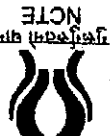
AND WHEREAS the order of the Appeal Committee was considered by the Northern Regional Committee in its 165th Meeting held from 1st to 2nd September, 2010 and the Committee decided as under:-

Issue order as per Appeal Committee decision for a basic unit of 100 students and for withdrawal of additional units.

5. NOW THEREFORE, the recognition of B. Ed. Add. Intake of R.K.S.D. College of Education Kaitthal, Ambala Road Kaitthal, Haryana, for the course in B.Ed. Add. Course is hereby withdrawn.

6. If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993.
