

## **ORDER**

WHEREAS, in terms of section 14(3)(a) of the NCTE Act, 1993, Kevla Nand B.ED College, Dara Nagar Ganj, Bijnor, Uttar Pradesh was granted recognition for **B.Ed.** Course of **one** year duration with an annual intake of 100 students on **28.05.2004** from the academic session **2004-2005**.

AND WHEREAS, the matter was placed before the NRC in its 157<sup>th</sup> meeting held on March 24-27, 2010 and the committee decided to close the file. Accordingly, withdrawal order dated 15.04.2010 was issued to the institution.

AND WHEREAS, the above said Institution, thereafter preferred an appeal dated 10.05.2010 to the Council (NCTE), New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.

AND WHEREAS, after perusal of documents, Memorandum of appeal, affidavit and VT Report, and considering oral arguments advanced during the hearing, the Council came to the conclusion that there is adequate ground to accept the appeal and reverse NRC's order dated 15.04.2010 and the Council vide order dated 19.07.2010 issued directions to NRC for restoring the recognition of the institution within 15 days of the issue of the order.

AND WHEREAS, the matter was placed before NRC in its 167th Meeting held on August 28-29, 2010 & the Committee decided to restore recognition to the institution.

NOW, THEREFORE, in compliance of order passed by the Appellate Authority and in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby restore recognition granted to Kevla Nand B.ED College, Dara Nagar Ganj, Bijnor, Uttar Pradesh for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students vide order No.NRC/NCTE/F-3/UP-1055 dated **28.05.2004**.
