WHEREAS, the I.P. College Of Education, Rithal Road, VPO- Jaisia, Distt- Rohtak, Haryana, was granted recognition for running D.Ed. Course of Two years duration with an annual intake of 50 students vide this office order no. F.NRC/NCTE/F-7/HR-742/27324-27330 dated 12.09.2007.

2. AND WHEREAS, the Show Cause notice under section 17 of NCTE Act was issued on 20.11.2009 with a direction to submit reply within 21 days.

3. The original file of the Institution, reply of the Institution along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 161st meeting held from 26th to 29th May, 2010 and the committee observes the following:


- Deficiencies communicated to the Institute through letter NRC / NCTE / F-3 / HR-374/ 151 Meeting / 2009 / 1192 dated 4 November 2009 still exist.
- Deficiencies communicated to the Institute through letter NRC / NCTE / F-3 / HR-742/ 151 Meeting / 2009 / 12537 dated 20 November 2009 still exist.
- Deficiencies communicated to the Institute through letter NRC / NCTE / F-3 / HR-892 / 151 Meeting / 2009 / 12133 dated 12 November 2009 still exist.
- The letter NRC / NCTE / F-3 / HR-932/ 151 Meeting / 2009 / 11922 dated 4 November 2009 has not been replied till date. Thus the deficiencies communicated to the Institute still exist.
- The letter NRC / NCTE / F-3 / HR-649/ 151 Meeting / 2009 / 14000 dated 22 December 2009 has not been replied till date. Thus the deficiencies communicated to the Institute still exist.
- The letter NRC / NCTE / F-3 / HR-595/ 151 Meeting / 2009 / 14815 dated 8 January 2010 has not been replied till date. Thus the deficiencies communicated to the Institute still exist.

4. Hence, the committee decides to withdraw recognition of D.Ed, B.Ed., B.Ed. additional, C.P.Ed., M.Ed. and B.P.Ed. Courses from academic session 2010 - 2011.

5. NOW THEREFORE, recognition to I.P. College Of Education, Rithal Road, VPO- Jaisia, Distt- Rohtak, Haryana, for the course in D.Ed. Course is hereby withdrawn from 2010-2011 academic session.

6. If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993
