WHEREAS, the Akbarpur Degree College, Akbarpur, Kanpur Dehat, U.P. was granted permission for running BTC course of two year duration with an annual intake of 50 students vide its office order no. F.NRC/NCTE/F-3/UP-1396/2004/8584-8592 dated 24.09.2004.

- AND WHEREAS, the inspection of the institution was conducted on 16.09.2006 under section 13 of the NOTE Act, 1993. The matter was placed before the committee in its 128th Meeting held on 09th to 10th April 2008 and the committee observed that the colleges are not running the specific teacher education course. The committee decided that the clarification be sought from the institution. Accordingly clarification letter was issued to the institution on 11.07.2008.
- AND WHEREAS the applicant institution has not submitted the representation to the NRC NCTE Jaipur. The matter was placed before the NRC in its 157th Meeting held on 24th to 27th March 2010 and the committee observes:
 - The Institution has not replied letter F.NO./ NRC/ NCTE/ F-3/ UP-1396/ 2008/54365 dated 11 July 2008.
- 4. AND WHEREAS, the committee decided to close the file.
- 5. NOW THEREFORE recognition to Akbarpur Degree College, Akbarpur, Kanpur Dehat, U.P. for the course in BTC in term of section 15(3)(b) of the NCTE Act, 1993 is hereby withdrawn.
- If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of 6. sections 18 of NCTE Act, 1993. **By Order**
