WHEREAS, the Excellent Degree College, Fatehpur, Sikri Road, Dakshini By pass Laramada, AgraZUIII U.P.- 283105 was granted permission for running B.Ed course of one year duration with an annual intake of 100 students vide its office order no. F.NRC/NCTE/F-3/UP-1238/2004/8332-8340 dated 22.09.2004.

- 2. AND WHEREAS, the inspection of the institution was conducted on 23.07.2006 under section 13 of the NCTE Act, 1993. The matter was placed before the committee in its 128<sup>th</sup> Meeting held on 09<sup>th</sup> to 10<sup>th</sup> April 2008 and the committee observed that the colleges are not running the specific teacher education course. The committee decided that the clarification be sought from the institution. Accordingly clarification letter was issued to the institution on 11.07.2008.
- 3. AND WHEREAS the applicant institution has not submitted the representation to the NRC NCTE Jaipur. The matter was placed before the NRC in its 157<sup>th</sup> Meeting held on 24<sup>th</sup> to 27<sup>th</sup> March 2010 and the committee observes:
  - The Institution has not replied letter F.NO./ NRC/ NCTE/ F-3/ UP-1238/ 2008/54332 dated 11 July 2008.
- 4. AND WHEREAS, the committee decided to close the file.
- 5. NOW THEREFORE recognition to Excellent Degree College, Fatehpur, Sikri Road, Dakshini By pass Laramada, Agra, U.P.- 283105 for the course in B.Ed in term of section 14(3) (b) of the NCTE Act, 1993 is hereby withdrawn.
- 6. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
