WHEREAS, in terms of section 14(3)(a) of the NCTE Act, 1993, recognition was granted to **SRM- Institute of Management & Technology, Delhi – Meerut Road, Sikri Kalan, Modi Nagar, Ghaziabad – 201204, Uttar Pradesh** for B.Ed. Course of one year duration with an annual intake of 100 students vide order F.NRC/NCTE F-3/UP-1203/2005/15499-15509 dated 16.03.2006.

AND WHEREAS, the said recognition was withdrawn by NRC vide order F.NRC/NCTE/F-3/UP-1205/161 meeting/2010/23638-23644 date 14.06.2010.

AND WHEREAS, the said Institution thereafter preferred an appeal before the Council (NCTE), New Delhi under section 18 of the NCTE Act, 1993, against the order of NRC F. NRC/NCTE F-3/UP-1205/23638-23644 dated 14.06.2010.

AND WHEREAS, the Council had passed order dated 24.09.2010 in the appeal filed by the institution. The order of NRC was reversed by the Council with direction to NRC to restore the recognition of the institution.

NOW, THEREFORE, in compliance of order passed by the council under section 18 of NCTE Act, 1993, and in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby restore the recognition granted to **SRM- Institute of Management & Technology, Delhi – Meerut Road, Sikri Kalan, Modi Nagar, Ghaziabad – 201204, Uttar Pradesh** for conducting B.Ed Course. With an annual intake of 100 (One hundred only) students vide order No.F.NRC/NCTE/F-3/UP-1055/2005/15499-15509 dated 16.03.2006.
