2. AND WHEREAS, the complaint against the Institution was received on **12.03.2010**.

3. The original file of the Institution, reply of the Institution along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the **Northern Regional Committee in its 161<sup>st</sup> meeting held from 26<sup>th</sup> to 29<sup>th</sup> May, 2010** and the committee observes the following:

- The Institute did not reply to the complaint sent to it vide letter number. **NRC / NCTE / F-7 / HR-1552 / 153 Meeting / 2009 / 1881 dated 26 March 2010**.

3. Hence, the committee decides to withdraw recognition of **D.Ed** as well as **B.Ed.** courses from 2010 - 2011 academic session.

5. NOW THEREFORE, recognition to **MARC College of Education, VPO- Lohani, Tehsil- Bhiwani, Distt- Bhiwani, Haryana**, for the course in **B.Ed.** Course is hereby withdrawn from 2010-2011 academic session.

6. If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993
