ORDER

1. WHEREAS, the **Shyam College of Education, Village- Panhera Kalan, PO- Fatehpur, Billoch, Teh. Ballabgarh, Dist- Faridabad, Haryana**, was granted recognition for running **B. ED.** Course of One year duration with an annual intake of **100** students vide this office order no. **F.NRC/NCTE/F-7/HR- 729/2007/28981-28987** dated **28.09.2007**.

2. AND WHEREAS, the inspection of the institution was conducted on **13.09.2009** under section 17 of the NCTE Act, 1993. Northern Regional Committee in its **161st meeting held on 26th to 29th May, 2010**, after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, decided to issue withdrawal order under section 17 of the NCTE Act, 1993. **Accordingly the Show Cause Notice under section 17 was issued on 22.06.2010.**

3. AND WHEREAS, The original file of the Institution, reply of the Institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the **Northern Regional Committee in its 163rd meeting held from 29th to 31st July, 2010** and the Committee observes the following:

- **The deficiencies communicated through letter number NRC / NCTE / F-7 / HR-729 / 161 Meeting / 2010/23953 dated 22 June 2010 still exist.**
- **The land is disputed as the matter is pending in the Civil Court.**

Hence the Committee decides to withdraw the recognition of B. Ed. programme from 2010 - 2011 academic session.

4. NOW THEREFORE, recognition to **Shyam College of Education, Village- Panhera Kalan, PO- Fatehpur, Billoch, Teh. Ballabgarh, Dist- Faridabad, Haryana**, for the **B. ED.** Course is hereby withdrawn from 2010-2011 academic session.

5. If the institution is not satisfied by the above order they can prefer and appeal to the Council in terms of section 18 of NCTE Act, 1993.
