

WHEREAS, the Shanti Niketan College of Business Management of Computer Science, Campus: N.H. - 3, Agra, Gawalior Road, Tehra, Agra - 1, Uttar Pradesh was granted permission for running BTC course of two year duration with an annual intake of 50 students vide its office order no. F.NRC/NCTE/F-3/UP-1463/2004/7144-7152 dated 28.08.2004.

AND WHEREAS, the inspection of the institution was conducted on 20.07.2006 under section 13 of the NCTE Act, 1993. The matter was placed before the committee in its 128^{th} Meeting held on 09^{th} to 10^{th} April 2008 and the committee observed that the colleges are not running the specific teacher education course. The committee decided that the clarification be sought from the institution. Accordingly clarification letter was issued to the institution on 15.07.2008.

AND WHEREAS, the applicant institution has not submitted the representation to the NRC NCTE Jaipur. The matter was placed before the NRC in its 157th Meeting held on 24th to 27th March 2010 and the committee decided to close the file. Accordingly, closure order issued on 13.04.2010 on the following grounds:-

 The Institution has not replied letter F.NO./NRC/ NCTE/ F-3/ UP-1463/ 2008/54675 dated 15 July 2008.

AND WHEREAS, the above said Institution, thereafter preferred an appeal before the Council under section 18 of the NCTE Act, 1993 against the aforesaid order of NRC and the case was remanded back to NRC by the Council vide order dated 10.06.2010.

AND WHEREAS, the matter was placed before NRC in its 162nd Meeting held form 24th to 27th June, 2010 & and decided that show cause notice be issued to the institution. Accordingly, Show-cause notice on 15.07.2010:-

 The list of Faculty appointed through dully constituted selection committee as per NCTE norms has not been submitted.

AND WHEREAS, the reply received was placed before NRC in its 163rd Meeting held on July 29-31, 2010 & and decided to withdraw the recognition of BTC programme from 2010 -2011 academic session. Accordingly, withdrawal order issued on the following grounds:-

From the reply of the Institute through letter number SNC/43/2010-2011 dated 3 July 2010, it is obvious that the BTC course was being run without qualified and dully appointed Faculty.

AND WHEREAS, the said institution had filed a writ petition No.58740/2010 and the court had passed an order dated 23.09.2010. In view of the order dated 23/09/2010 passed by the Hon'ble High Court of Allahabad, the reply dated 30/07/2010 submitted by the institution after the decision of appellate body granting it 3 months time to appoint faculty was carefully considered by NRC and it was decided to issue Show Cause Notice under section 15 (3) (b) of NCTE act, 1993 on the following grounds:-

The Principal appointed by the institution does not possess the required experience of teaching in Elementary Teacher Training institution for a period of 5 years. Smt. Sarika Uppadhaya appointed as Principal / HOD does not have the experience of teaching in ance with Clause 6 of Appendix 9 of NCTE Regulation 2009.



AND WHEREAS, the institution's reply dated 22.11.2010 with reference to the Show Cause Notice has been carefully considered by NRC, in its 174^{th} Meeting held on 08^{th} to 10^{th} December, 2010 and committee decided that the institution may be allowed to continue the recognition, as granted earlier vide NCTE letter dated 29.08.2004 in supersession to the NRC order dated 13.04.2010 withdrawing the recognition the institution for the BTC course.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby restore recognition granted to Shanti Niketan College of Business Management of Computer Science, Campus: N.H. - 3, Agra, Gawalior Road, Tehra, Agra - 1, Uttar Pradesh for conducting B.T.C. Course of Elementary (Level) of two year duration with an annual intake of 50 (Fifty Only) students vide order F.NRC/NCTE/F-3/UP-1463/2004/7144-7152 dated 28.08.2004.

The other terms and conditions will remain same as mentioned in the recognition order dated 28.08.2004.
