Stone, Bhopa Road, Shanti Nagar, Mustafabad, Muzaffar Nagar- 251001, Uttar Pradesh; and subsequent decision taken by NRC in its 162nd Meeting held from June 24-27, 2010 & NCTE hqrs vide clarification letter No.89-337/2009-Appeal/A23965 dated 08.09.2010, the paragraph-6 of NRC order No. F.NRC/NCTE/F-7/UP-1845/162 MEETING/2010/ 25335 dated 09.07.2010 i.e. "NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Deen Dayal College, 4th KM. Stone, Bhopa Road, Shanti Nagar, Mustafabad, Muzaffar Nagar- 251001, Uttar Pradesh for conducting an additional unit of 100 seats of B.Ed. course of Secondary (level) of one year duration making the existing annual intake of 100 students to 200 students from the academic session 2009-2010 under clause 7(11) of NCTE Regulations, 2007 notified on 10-12-2007.

- (i) Order for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/affiliating body.
- (ii) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only."
