WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Ram Pratap Rang Lal Institute of Management and Technology, Plot No.1184, 1185, 1186, 1187 & 1189, Lakhimpur Road, Vill-Narshohi, Post- Sahmaholi, Tehsil-Sitapur, District-Sitapur-261001, U.P. had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of One year duration with an annual intake of 100 (One hundred Only) students on

AND WHEREAS, the Inspection of the said institution under section 14 was conducted by visiting team on 30.07.2009.

AND WHEREAS, NRC in its 146<sup>th</sup> Meeting held from August 05-07, 2009, after considering the visiting report as well as other relevant materials furnished by the applicant institution decided to issue Show Cause Notice to the applicant institution on 12.08.2009.

AND WHEREAS, the applicant institution has submitted representation to Northern Regional Committee, NCTE on 31.08.2009. The original file of the institution as well as other documents and materials submitted by the institution along with VTR, videography were again duly considered by the NRC in its 149th Meeting held on September 13-14, 2009 and the committee decided to send VT to verify the facts.

AND WHEREAS, the re-inspection of the said institution under section 14 was conducted by visiting team on 03.02.2010.

AND WHEREAS, NRC in its 158<sup>th</sup> Meeting held from April 19-22, 2010, after considering the visiting report as well as other relevant materials furnished by the applicant institution decided to close the file. Accordingly, refusal order issued on 12.05.2010 on the following grounds:-

As per CD the building seems to be incomplete. Further, the building completion certificate from competent authority has not been submitted.

The equipments in science lab, psychology lab and ET lab were kept on the table. Thus, proper labs are not developed.

As per VT report, the size of Principal's room and office are small.

Titles in the library are not as per NCTE norms for B.Ed.

Play grounds are not developed properly.

AND WHEREAS, the institution, thereafter preferred an appeal dated 13.05.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council reached the conclusion that there was adequate ground to accept the appeal and set aside NRC's order dated 12-05-10. Accordingly, the appeal was accepted and the case remanded back to NRC vide order dated 19.07.2010 with the direction to issue Letter of Intent prior to grant of recognition within 15 days of issue of this order.

AND WHEREAS, the said order was placed in the 164th Meeting held on August 28-29, 2010 and it was decided that orders to be issued as per the decision of the Appellate authority. Accordingly, Letter of intent prior to recognition issued on 05.10.2010.

AND WHEREAS, the reply dated 07.11.2010 received in response to letter of intent was considered by NRC in its  $175^{th}$  Meeting held on December 30-31, 2010. After considering the minutes of the Selection Committee, comprising of experts nominated by the University and the approval of the University for the appointment of faculty, it was decided to issue recognition to the institution for B.Ed. course with an annual intake of 100 students under clause 7(11) of NCTE Regulations 2009 and in terms of section 14(3)(a) of the NCTE Act, 1993 subject to the usual

AND WHEREAS, the NCTE has issued letter No.48-6/PT-III/ NCTE (N&S) dated 31.08.2010 in which it was stated that the matter regarding issue of recognition order under clause 7(9) or 7(11) of NCTE Regulations to the institution which were found eligible for grant of recognition order on merit but where order could not be issued due to the ban imposed by the NCTE on 26th July, 2009 has been considered by the Council and it is clarified that such pending orders now be issued. This is due to the consideration that the present ban is only on fresh receipt of application for the academic session 2011-2012 and therefore the old pending cases are to be disposed on merit without any reference to the ban.

AND WHEREAS, the above letter of NCTE, Headquarter was considered by NRC in its 166th Meeting held on 9th September, 2010 and NRC decided that the recognition order under section 7 (11) of NCTE, Regulations in all such pending cases where NRC or Council (NCTE) had decided to grant recognition under section 7 (11) of NCTE Regulations be issued from the session 2010-2011 subject to the following condition:-

The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.

Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Ram Pratap Rang Lal Institute of Management and Technology, Plot No.1184, 1185, 1186, 1187 & 1189, Lakhimpur Road, Vill- Narshohi, Post- Sahmaholi, Tehsil-Sitapur, District-Sitapur-261001, U.P. for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions:-

The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.

Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
