WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, S.G.R. Mahavidyalaya, VPO-Talgram, Tehsil- Chibramau, District- Kannauj, Uttar Pradesh has submitted an application to the NRC for grant of recognition/permission for conducting B.Ed Course of one year duration with an annual intake of 100 (One Hundred only) on 24.10.2008.

AND WHEREAS, deficiency letter issued to the institution on 29.12.2008. The original file of the institution, reply of deficiency letter and other related documents, Act of NCTE, 1993 Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 140<sup>th</sup> Meeting held on April 25-26, 2009 and the Committee decided to close the file and return the FDRs. Accordingly, Closure order issued to the institution on 25.07.2009 on the following grounds:-

- Resolution of Panchayat regarding approving of building plan not submitted
- CLU not submitted

AND WHEREAS, the above said Institution, thereafter preferred an appeal dated 18.08.2009 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 08.10.2009 accepted the appeal and remand back the case to NRC for causing inspection of the institution within one month of issue of this order to ascertain the adequate availability of infrastructure and other facilities as per NCTE norms and thereafter pass appropriate order.

AND WHEREAS, the said order was placed in the 151st Meeting held on October 20-21, 2009 and it was decided to implement the decision of appeal committee.

AND WHEREAS, Inspection of the institution conducted on 09.02.2010. The original file of the Institution, VTR along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 157th meeting held on March 24-27, 2010 and the committee decided to issue show cause notice to the institution. Accordingly, Show-cause notice issued on 13.04.2010 on the following grounds:-

- The college is running BA classes in the same premise.
- The sight and location maps are not submitted.
- Steps for veranda and building are not constructed.
- Original land documents were not shown to VT members.

AND WHEREAS, the original file of the institution, reply received along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 159<sup>th</sup> meeting held on April 28-May-01, 2010 and the committee decided to refuse recognition to B.Ed. programme and return FDRs if submitted. Accordingly, Refusal order issued to the institution on 03.06.2010 on the following grounds:-

- The deficiencies communicated to the Institution through letter number F.NRC / NCTE / F-3 / HR-335 / 156 meeting / 2010/ 18710 dated 18 March 2010 still exist.
- The building submitted does not indicate khasra number / plot number.
- CLU has not been submitted.

AND WHEREAS, the above said Institution, again preferred an appeal dated 16.06.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 24.09.2010 accepted the appeal and reverse the order of the NRC dated 03.06.2010 with a direction to issue Letter of intent prior to recognition under clause 7(9) of the NCTE Regulations within 15 days of issuance of the appellate order. Accordingly, Letter of intent prior to recognition issued to the institution on 18.11.2010.

AND WHEREAS, the reply of the institution received consequent upon the issue of Letter of intent prior to recognition under clause 7(9) dated 18.11.2010 was considered by NRC in its  $177^{th}$  Meeting held from January 27-29, 2011 and it was decided to issue formal recognition order for B.Ed. course under clause 7(11) and in terms of section 14(3)(a) of the NCTE Act, 1993 subject to the usual terms and conditions.

AND WHEREAS, the NCTE has issued letter No.48-6/PT-III/ NCTE (N&S) dated 31.08.2010 in which it was stated that the matter regarding issue of recognition order under clause 7(9) or 7(11) of NCTE Regulations to the institution which were found eligible for grant of recognition order on merit but where order could not be issued due to the ban imposed by the NCTE on  $26^{th}$  July, 2009 has been considered by the Council and it is clarified that such pending orders now be issued. This is due to the consideration that the present ban is only on fresh receipt of application for the academic session 2011-2012 and therefore the old pending cases are to be disposed on merit without any reference to the ban.

AND WHEREAS, the above letter of NCTE, Headquarter was considered by NRC in its 166<sup>th</sup> Meeting held on 9<sup>th</sup> September, 2010 and NRC decided that the recognition order under section 7 (11) of NCTE, Regulations in all such pending cases where NRC or Council (NCTE) had decided to grant recognition under section 7 (11) of NCTE Regulations be issued from the session 2010-2011 subject to the following condition:-

- The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to S.G.R. Mahavidyalaya, VPO- Talgram, Tehsil- Chibramau, District- Kannauj, Uttar Pradesh for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions:-

- The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
