ORDER

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 AMITY UNIVERSITY (DEPARTMENT OF PHYSICAL EDUCATION), GAUTAM BUDH NAGAR, UTTAR PRADESH had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.P.Ed. Course of One year duration with an annual intake of 50 (Fifty Only) students on 30.12.2005.

AND WHEREAS, the original file of the institution as well as other documents and materials submitted by the institution alongwith VTR, videography were duly considered by the NRC in its 109th Meeting and 110th Meeting held from November 10-12, 2006, the committee decided to issue conditional recognition subject to appointment of faculty members as per NCTE norms and accordingly, order was issued to the institution vide NCTE letter No.NRC/NCTE/F-7/8371-79 dated 14.11.2006.

AND WHEREAS, the original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered by NRC in its 141st Meeting held on May 22-24, 2009 and the committee decided to refuse recognition and return FDRs, if submitted. Accordingly, refusal order was issued to the institution on 09.07.2009:-

The list of appointed Faculty as per NCTE Norms has not been submitted till date.

AND WHEREAS, the above said Institution, thereafter preferred an appeal dated 31.07.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 08.10.2009 accepted the appeal and remand back the case to NRC for issue a revised order specifying that the withdrawal of conditional recognition accorded to the institution vide NRC's order dated 14-11-06 would be effective from the academic session 2010-2011. Accordingly, order was issued to the institution on 01.12.2009.

AND WHEREAS, the institution vide letter dated 13.12.2010 has submitted a copy of the court order dated 05.08.2010 in Writ Petition No.3293 of 2010.

AND WHEREAS, in compliance of order passed by the Hon'ble Court, the Northern Regional Committee decided to issue fresh formal recognition in continuation to the earlier conditional order dated 14.11.2006. However, as per NCTE Regulations for one unit of 50 students of B.P.Ed. course, the required faculty is 1 Principal and 5 lecturers. Since the list of Faculty/lecturers submitted by the institution indicates that they have only 4 lecturers in position, the institution may be given Show Cause Notice under section 17 of the NCTE Act, 1993 to explain as to why their recognition may not be withdrawn.
