#### **ORDER**

WHEREAS, Modern College of Professional Studies, 137, Navyug Market, Ghaziabad, Uttar Pradesh had submitted an application to the NRC for grant of recognition/permission for conducting B.Ed Course of One year duration with an annual intake of 100 (One Hundred only) on 21.02.2007 and the NRC granted permission to the institution for conducting B.Ed Course for one Year duration with an annual intake of 100 Students, vide order no. F.NRC/NCTE/F-3/UP-719/2003/2414-2422 dated 03.07.2003.

AND WHEREAS, a letter dated 11.08.2008 received from NCTE hqrs regarding complaint against the said institution, was placed in the 136<sup>th</sup> Meeting of NRC held from January 19-21, 2009 and it was decided to issue Show-cause notice to the institution. Accordingly, Show-cause notice was issued to the institution on 23.01.2009 to submit documentary proofs on the following points:-

- Change of land use.
- Status of demolition order by Distt. Magistrate.
- Status of shifting of premises from rent to permanent site.

AND WHEREAS, reply received from the institution was placed in the 141<sup>st</sup> Meeting of NRC held from May 22-24, 2009 and it was decided to take legal opinion on the land documents.

AND WHEREAS, the matter was again placed in the 153<sup>rd</sup> Meeting held on December 11-12, 2009 and it was decided that VT may be constituted.

AND WHEREAS, the inspection of the institution was conducted under section 17 on 10.03.2010. The original file of the Institution, VTR of the Institution along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 160<sup>th</sup> meeting held from May 18-20, 2010 and the committee decided to issue Show-cause notice to the institution. Accordingly, Show-cause notice was issued to the institution on 01.06.2010 on the following grounds:-

- Approved building plan indicating course-wise demarcated area is to be submitted.
- Dr. Nisha Singh appointed as Principal has not submitted affidavit of Rs. 10 along with necessary documents.
- The number of titles of books in the library is not as per NCTE norms for B.Ed.
- Fifty computers are not enough for 200 B.Ed. students and three years BCA course, and BBA Course students.

AND WHEREAS, the original file of the Institution, reply of the Institute along with all other related documents, act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 162<sup>nd</sup> Meeting held from June 24-27, 2010 and the committee decided to withdraw the recognition of B.Ed. course from academic session 2010 - 2011. Accordingly, withdrawal order issued to the institution on 10.08.2010 on the following grounds:-

 The deficiencies communicated to the Institute through letter number NRC / NCTE / Up-719 / 160 meeting / 2010 / 22944 dated 1 June 2010 still exist.

AND WHEREAS, the above said Institution, thereafter preferred an appeal dated 12.07.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 12.11.2010 accepted the appeal and reversed the NRC's order dated 10.08.2010 with a direction to restore the recognition to the appellant institution.

NOW, THEREFORE, in compliance of order passed by the Appellate Authority and in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby restore recognition granted to Modern College of Professional Studies, 137, Navyug Market, Ghaziabad, Uttar Pradesh for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students.

The other terms and conditions will remain same as mentioned in the recognition order dated 03.07.2003.
