ORDER

WHEREAS, Pramod Mahavidyalalya, Mehrara, District – Hathras, Uttar Pradesh had been granted recognition by Appellate Authority, NCTE, New Delhi vide order No.42-40/98-99-NCTE/4875 dated 20.07.1999 followed by NRC, NCTE order No.F-3/UP-95/B.Ed/2000/4134-41 dated 24.07.2000 for starting B.Ed. Course of One year duration with an annual intake of 90 (Ninety only) seats.

AND WHEREAS, the inspection of the institution u/s 13 was conducted on 30.10.2001 and the Northern Regional Committee in its 64th Meeting held from 05th and 06th June, 2003 considered the matter and the committee decided to withdraw the recognition of the institution. Accordingly letter was issued vide order No.NRC/NCTE/F-3/1575-1582 dated 17.06.2003.

AND WHEREAS, the institution had filed a writ petition No.54412 of 2009 in the High Court of Allahabad against order dated 17.06.2003 passed by NRC. The Court had passed an order dated 21.10.2009.

AND WHEREAS, the matter was placed in the 153rd Meeting held on December 11-12, 2009 and it was decided that VT may be constituted. Accordingly, inspection conducted on 15.04.2010.

AND WHEREAS, the VTR alongwith original file was placed in the 162nd Meeting held on June 24-27, 2010 and it was decided to issue Show-cause notice on certain points.

AND WHEREAS, the reply of the institution dated 21.07.2010 w.r.t the points of Show Cause Notice was placed before NRC, in its 174th Meeting held from 08th to 10th December, 2010 and committee observed that in its reply, the Institution submitted a copy of the nomination of Subject Expert by Dr. Bhim Rao Ambedkar University, Agra dated 5.3.2009 has been submitted to substantiate its claim that selection of the faculty made by it was in accordance with due procedure prescribed for the purpose. The reply has been accepted. As such, the orders of NCTE dated 17.06.2003 be recalled and set null and void in compliance of orders of the Hon'ble Court dated 21.10.2009.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby restore recognition granted to Pramod Mahavidyalalya, Mehrara, District – Hathras, Uttar Pradesh for conducting B.Ed. Course of Secondary (Level) of one year duration with an annual intake of 90 (Ninety only) seats vide order No.F-3/UP-95/B.Ed/2000/4134-41 dated 24.07.2000.
