ORDER OF RESTORATION OF RECOGNITION

3 1 AUG 2012

WHEREAS in terms of section 14(1) of the NCTE Act, 1993 Baba Mehar Singh Memorial Society, VPO-Purana Shalla, Tehsil-Gurdaspur, Punjab has submitted on application (Code No. PB-209) to the Northern Regional Committee of NCTE for grant of recognition for running B.Ed. Course of one year duration with an annual intake of 100 (One Hundred Only) seats vide order No. F.NRC/NCTE/F-3/PB-209/1912-21 dated 26.05.2005 in the name of Baba Mehar Singh Memorial College of Education, VPO-Purana Shalla, Gurdaspur-143530, Punjab.

AND WHEREAS, Guru Nanak Dev University, Amritsar vide letter dated 21.06.2011 has submitted inspection report of this college requesting this office to take immediate action regarding withdrawal of its recognition and consequent disaffiliation by treating the said report as representation in terms of section 17 of the NCTE Act 1993.

AND WHEREAS, the matter was considered by NRC in its 185th meeting held from July 26-31, 2011 and it was decided to issue Show Cause Notice under section 17 of the NCTE Act, 1993. Accordingly, notice was issued to the institution on 06.09.2011 on the following points:-

- 1. The Institution is not having adequate faculty including Principal, as per NCTE Norms and is this not conducting the course in accordance with NCTE Norms.
- 2. The Institution is not have well earmarked and adequate space to conduct the B.Ed. Course.

AND WHEREAS, reply received from the institution in response to the aforesaid notice was considered by NRC in its 189th Meeting held from November 24-28, 2011 and it was decided to withdraw the recognition of the institution under section 17(1) of the NCTE Act, 1993. Accordingly, recognition of the institution was withdrawn vide NRC order dated 11.01.2012 on following ground:-

• The institution failed to submit the teaching staff list duly approved by the concerned affiliating University. Moreover, the institution has not appointed the required faculty as per the NCTE norms. The institution has also failed to prove having required well earmarked and adequate space to conduct the B.Ed. course. The same has also been clearly established by the letter dt.21.6.2011 of the Guru Nanak Dev University, Amritsar. All such violations clearly reveal that the institution is being run in violation of the provisions of the NCTE Act, Rules & Regulations.

AND WHEREAS, the institution thereafter, preferred an appeal dated 16.02.2012 to the Council (NCTE) New Delhi against the aforesaid order. The council vide order dated 18.04.2012 accepted the appeal and remanded the matter to the NRC with a direction to the NRC to conduct comprehensive inspection of the institution after obtaining payment of Rs. 40,000 from the institution and to take further action thereafter.

AND WHEREAS, a letter dated 25.04.2012 received from the institution in NRC office on 02.05.2012 alongwith the inspection charges of Rs. 40,000/- (DD No. 037287).

AND WHEREAS, the matter was placed in NRC 199th Meeting held from 22nd to 27th May, 2012 and the committee decided that after receiving Rs. 40,000- V.T. be reconstituted for inspection. Accordingly the inspection of the institution was conducted u/s 17 the NCTE Act, 1993 on 29.06.2012.

AND WHEREAS, the matter was considered by NRC in its 202nd meeting held from 25th to 28th July, 2012 and it was decided that the application be recognition restored the institution on the followings points:-

Recognition for B.Ed. course is restored from the date of withdrawal of recognition.

NOW THEREFORE, the above recognition of Baba Mehar Singh Memorial College of Education, VPO-Purana Shalla, Gurdaspur-143530, Punjab for B.Ed. Course is hereby restored.
