- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
  - Copy of the Application Form
  - Land and Building Particulars (ii)
  - Staff Profile (iii)
  - Recognition letter (iv) ....
  - Information for having fulfilled the norms & standard and other required conditions.
  - In case if the land is in the name of the Society/trust, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated
