**ORDER**

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the institution **Vaidh Shankar Lal Memorial College of Education, Village & Post – Chandhi, Tehsil – Kasauli, Dist. – Solan, Himachal Pradesh - 173206** was recognized by NRC vide its Order No. NRC/NCTE/F-7/HP-179/5051 dated 23.08.2006 for B.Ed. course for 100 seats.

3. AND WHEREAS, the institution **Vaidh Shankar Lal Memorial College of Education, Village & Post – Chandhi, Tehsil – Kasauli, Dist. – Solan, Himachal Pradesh - 173206** has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed. which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to **Vaidh Shankar Lal Memorial College of Education, Village & Post – Chandhi, Tehsil – Kasauli, Dist. – Solan, Himachal Pradesh - 173206** for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.


6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (a) Sanctioned programmes along with annual intake in the institution.
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

ORDER

Whereas recognition was granted to the institute Vaidh Shankar Lal Memorial College of Education, Vill & Post - Chandī, Tehsil - Kasauli, Distt. - Solan, Himachal Pradesh - 173206 under section 15(3) (a) of NCTE Act, 1993 for conducting B.ED. course with an annual intake of 100 (One Hundred) vide order No. F.NRC/NCTE/F-3/HP-179/2006/50/51 dated 23.08.2006.

And whereas the matter was placed before the Northern Regional Committee in its 143<sup>th</sup> meeting held on 27<sup>th</sup> to 29<sup>th</sup> June, 2009 and the committee decided to Conducted inspection under section 17 of the institution . The Northern Regional Committee had constituted a Visiting Team to visit the institution u/s 17, which has visited the institute on 12.08.2009. Upon consideration of the report submitted by the visiting team, perusal of videography and other materials furnished by the institution along with the application, the Northern Regional Committee in its 161<sup>nd</sup> meeting held on 26<sup>th</sup> - 29<sup>th</sup> May, 2010 decided to issue Show Cause Notice and Show Cause Notice issued was on 15 July 2010. Reply of Show Cause Notice was received on 29.06.2010.

And whereas the matter was placed before the Northern Regional Committee in its 163<sup>th</sup> meeting held on 29<sup>th</sup> to 31<sup>th</sup> July, 2010 and the committee observed the following:

- Except Computers, the deficiencies communicated through letter number NRC / NCTE / HP-203 / 161 Meeting / 2010 / 25670 dated 16 July 2010 still exist.
- Except Computers, the deficiencies communicated through letter number NRC / NCTE / HP-179 / 161 Meeting / 2010 / 25602 dated 15 July 2010 still exist.
- Except Computers, the deficiencies communicated through letter number NRC / NCTE / HP-199 / 161 Meeting / 2010 / 25815 dated 21 July 2010 still exist.

**Hence the committee decided to withdraw the recognition of ETT, B.Ed. and M.Ed. programmes from the academic session 2010 - 2011.**

Now, therefore recognition Vaidh Shankar Lal Memorial College of Education, Vill & Post - Chandī, Tehsil - Kasauli, Distt. - Solan, Himachal Pradesh - 173206 for the B.ED. course in terms of Section 15(3) (a) of the NCTE Act, 1993, is hereby withdrawn from the academic session 2010-2010.
