ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution Modern Indian College of Education, Vill- Pali, Post- Kund, Tehsil- Rewari, Distt- Rewari, Haryana was recognized by NRC vide its Order No. NRC/NCTE/HR-1053/2009/62034-40 dated 22nd March 2009 with an annual intake of 100 seats.
- AND WHEREAS, the institution has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which requires additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (i) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The application-Institution for additional unit will be required to submit the required documents such as (ii) land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of
 - The Regional Committees shall arrange for verification of documents, inspection of these premises and (iii) check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the (iv) NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Modern Indian College of Education, Vill- Pali, Post- Kund, Tehsil-n Rewari, Distt- Rewari, Haryana for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993 MODERN INDIAN COLLEGE OF EDUCATON, VILLAGE - PALI, POST - KUND, TEHSIL - REWARI, DISTRICT - REWARI, HARYANA. has submitted an application (code No.Apn04989) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. course of One year duration with an annual intake of 100(one hundred only) students on 8.11.2007.

- AND WHEREAS the competent authority had constituted Visiting Team to visit
 the Institution and the Visiting Team which visited the Institute on 10th May, 2008
 has since submitted its report.
- 3. AND WHEREAS in its 131st 2nd Meeting held on 21st Aug, 2008 the Northern Regional Committee after considering the report of the Visiting Team perusal of Videography as well as other relevant materials furnished by the applicant institution was satisfied that the application does not fulfill the requirements and issued a notice on 23rd Aug, 2008 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 4. AND WHEREAS the applicant institution had submitted representation dated 27th Aug, 2008, to the NRC, NCTE. The Said representation of the institution as well as other document and materials submitted by the institution along with VTR and Videography were again duly considered by the Northern Regional committee on 29th -31st Aug 2008, which came to the conclusion that recognition/permission to the said institution be refused for the following reasons.
- (I) THE COVERED AREA SHOWN IN THE PREVIOUSLY SUBMITTED MAP AND NOW SUBMITTED MAP DOES NOT MATCH. IT IS NOT CLEAR HOW THE COVERED AREA HAS BEEN INCREASED.
- 5. AND WHEREAS grant of recognition/permission to Modern Indian College of Education, Vill- Pali, Post- Kund, Tehsil- Rewari, Distt- Rewari, Haryana for the course in B.Ed in terms of Section 14(3) (b) of the NCTE Act, 1993 was refused vide order No - F.NRC/NCTE/HR-1053/2008/62034-62040 dated 16.09.2008.
- AND WHEREAS Secretary of Modern Indian Shiksha Samiti Modern Indian college of Education preferred an appeal dated 05.09.2008 to the NCTE, New Delhi Under Section 18 of the NCTE Act, 1993 against the above said order.

- 7. AND WHEREAS the council noted the VTR is favorable and institution has four kanal (0.5 acre land) in the name of the Society and also has sufficient built up area to run the proposed and the existing teachers training course I. e. B.Ed and D.Ed course.
- 8. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report, and after hearing oral arguments advanced during the hearing, the council felt that there was adequate ground to accept the appeal. Accordingly, the appeal was accepted and the NRC's order dated 16.09.2008 was reversed with the direction to the NRC to grant recognition to the institution immediately.
- NOW, THEREFORE, in compliance order F. No-89-296/2008-Appeal dated 10.11.2008 passed by the appellate authority the order or recognition under 7(11) of the Regulation 2007 is issued.
- 10. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts in to joint accounts to be operated along with an officer of the Northern Regional Committee.
- 11. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10.12.2007.
- 13. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the state Government etc, wherever applicable.
