AND WHEREAS, the aforesaid order having been reversed by the Appellate Authority, NCTE-New Delhi vide its order dated 28th September, 2005 in an appeal preferred by the institution under section 18 of the NCTE Act, 1993, the NRC in its 97th meeting held on 27th and 28th October, 2005 has decided to implement the aforesaid decision of the NCTE.
- 3. NOW THEREFORE, in exercise of the powers vested under Section 15 (3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Amity Institute of Education, Amity Campus, Road No. 44, M-Block, Saket, New Delhi for NTE course of two years duration w.e.f. 28th October, 2005 with an annual intake of 50 (Fifty) students in the 1st year and the same for the 2nd year subject to fulfillment of the following:-
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/State Govt./UGC/SCERT is to be completed before commencement of the session.

(b) The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session.

(c) The institution shall adhere to all other regulations and guidelines as framed by NCTE from time to time.

(d) The institution shall within one month of the receipt of this order, convert the Endowment Fund account into a joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a
