AND, WHEREAS, as per the Guidelines issued by NCTE Hqrs., the institution submitted affidavit for compliance of NCTE Regulations, 2014.

AND, WHEREAS, the institution was issued revised order on 05.06.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students. (two basic units of 50 students each) from the academic session 2015-2016.

AND, WHEREAS, the institution submitted an affidavit on 02.02.2017 with a request to reduce the seats of B.Ed. Course from two basic units of 50 students each to one basic units of 50 students each.

AND, WHEREAS, the matter was placed before the NRC in its 265th meeting(Part-1) held from 27th February to 03rd March, 2017. The Committee considered the matter and decided that the request of the institution to reduce the number of seats from 100 (two basic units of 50 students each) to 50 (one basic units of 50 students each) to run B.Ed. course is accepted from the next academic session i.e. 2017-18.

NOW, THEREFORE, the Northern Regional Committee hereby reduces the number of seats of B.Ed. course from 100 (two basic units of 50 students each) to 50 (one basic units of 50 students each) of **Baba Kirpal Dass College of Education for Women, Tehsil- Paonta Sahib, Dist.- Sirmour, State- Himachal Pradesh, Pin Code- 173025** from the academic session 2017-18.



WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the institution **Baba Kirpal Dass College of Education for Women, Tehsil – Paonta Sahib, Dist. – Sirmour, Himachal Pradesh - 173025** was recognized by NRC vide its Order No. NRC/NCTE/F-3/HP-83/14255-264 dated 10.03.2005 for B.Ed. course for 100 seats.

3. AND WHEREAS, the institution **Baba Kirpal Dass College of Education for Women, Tehsil – Paonta Sahib, Dist. – Sirmour, Himachal Pradesh - 173025** has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed. which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.


Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised recognition Order to **Baba Kirpal Dass College of Education for Women, Tehsil – Paonta Sahib, Dist. – Sirmour, Himachal Pradesh - 173025** for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc, as applicable.

 - The affidavit with enclosure submitted along with application.
 - The institution shall be free to post additional relevant information, if it so desires.
