ORDER

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. **AND WHEREAS**, the institution **Maharaja Lakshman Sen Memorial College, Sunder Nagar – I, Dist. – Mandi, Himachal Pradesh - 174401** was recognized by NRC vide its Order No. NRC/NCTE/F-3/HP-75/5408 dated 06.07.2005 for B.P.Ed. course for 50 seats.

3. **AND WHEREAS**, the institution **Maharaja Lakshman Sen Memorial College, Sunder Nagar – I, Dist. – Mandi, Himachal Pradesh - 174401** has by affidavit consented to come under New Regulations and sought for one basic unit in B.P.Ed. which require additional facilities.

4. **AND WHEREAS**, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. **Now therefore**, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to **Maharaja Lakshman Sen Memorial College, Sunder Nagar – I, Dist. – Mandi, Himachal Pradesh - 174401** for conducting B.P.Ed. programme of two years duration with an annual intake of 50 for one basic unit of 50 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.


7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (a) Sanctioned programmes along with annual intake in the institution.
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS, on the application submitted by the institution, namely, **Maharaja Lakshman Sen Memorial College, Sundernagar - I, Mandi, Himachal Pradesh - 174401**, the NRC in exercise of powers vested in it under section 14 (3) (a) of the NCTE Act, 1993 and being satisfied that the institution fulfills the requisite requirements for the proposed teacher training course, was pleased to grant recognition to the said institution vide its communication No. F. NRC/NCTE/F-3/HP-75/2979-2987 dated 18th July 2003 to start B.P.Ed. course of one year duration with an annual intake 50 (Fifty) seats from academic session 2003-2004 subject to fulfillment of certain conditions enumerated in the order. Subsequently the above order was withheld by NRC vide communication dated November 12, 2003 on receipt of a letter from the State Government to the effect that the concerned University had not finalized approval of syllabi of the course as yet.

2. Now, the Deputy Registrar (Academic) of Himachal Pradesh University has intimated that the B.P. Ed. course and syllabi of study has been approved by the Academic Council of the university and the NRC in its 90th meeting taking into consideration the above and the fact that the fee structure is likely to be decided by the State government soon as informed by the State representative decided to issue fresh recognition order to the institution,

3. THEREFORE, in exercise of the powers vested under section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Maharaja Lakshman Sen Memorial College, Sundernagar - I, Mandi, Himachal Pradesh - 174401** for B.P. Ed. course with an annual intake 50 (Fifty) seats w.e.f. 23rd April, 2005 subject to compliance of the following conditions before commencement of the academic session,

(a) Appointments of the duly qualified faculty members and staff as per the norms of NCTE/ State Government/ U.G.C. are to be completed before the commencement of the session.

- (b) The countersigned statement of all faculty members from the Registrar of the concerned University shall be submitted before commencement of the academic session.
- (c) The institution shall adhere to all the regulations and guidelines issued by the NCTE from time to time.
- (d) The institution shall within one month of receipt of this order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank to be operated only along with an official of the Regional Committee.
- (e) Reserve Fund for an amount equal to three months salary of the teachers and staff shall be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.

4. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / U.G.C. / Affiliating University.

5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like U.G.C. and State Government, etc.

6. The institution shall submit to the Regional committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, 1993, rules, Regulations and/or order made or issued there under, The Regional Committee may withdraw the recognition under the provisions of Section 17 (1) of the NCTE Act, 1993.
