WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, the Society namely, Surajmal Memorial Educational Society, C-4, Janakpuri, New Delhi-110058 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/seeking permission to the institution i.e. Maharaja Surajmal Institute, C-4, Janakpuri, Delhi-110058 for ETE. Course. The institution was granted recognition to the ETE Course for an annual intake of 50 (Fifty Only) students vide order No F. NRC/NCTE/F-3/DH-242/2004/9276-9284 dated 13.10.2004.

AND WHEREAS, a letter no. SMES/2015/188/529 dated 30.05.2015 received from the Shri S.P. Singh, President, Maharaja Surajmal Education Society, C-4, Janakpuri, Delhi-110058 on 19:06.2015 mentioned the following:-

"This is to bring to your kind notice that Maharaja Surajmal Institute have been running D.El.Ed. course affiliated to SCERT since 2005. But from this session onwards, i.e. 2015-16 the institute wants to discontinue this course, It is therefore requested that admissions in this course from the session 2015-16 should not be allotted to this institute. Performa for closer of D.El.Ed. Programme and the Resolution to this effect is also enclosed."

AND WHEREAS, the matter was placed before the Northern Regional Committee in its 240th Meeting held from 20th to 22nd July, 2015. The NRC after considering the matter in detail observed/decided the following: -

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.

Request of the institution for withdrawal of D.El.Ed. course is accepted. FDRs, if any, be returned to the institution.

NOW THEREFORE, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby withdraw the proposal of D.El.Ed. course to the institution i.e. Maharaja Surajmal Institute, C-4, Janakpuri, Delhi-110058 on the grounds mentioned above.



Maharaja Surajmal Institute, C·4, Janakpuri, Delhi – 110 058 had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for starting ETE Course of two years duration in terms of Section 15(1) of the NCTE Act, 1993.

- 2. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Maharaja Surajmal Institute, C-4, Janakpuri, Delhi – 110 058 for ETE course of Two years duration w.e.f. 6th October 2004 with an annual intake of 50 (Fifty) students in the 1st year and the same for the IInd year subject to fulfillment of the following before commencement of the session:
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE / State Govt. / SCERT is to be completed before the commencement of the academic session.
 - (b) The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic
 - (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional committee.
 - (e) That the Reserve Fund for an amount equal to three months salary of the teachers & staff be created within one month from the date of issue of this order and maintained in the form of FDR in favor of the management/institution, for a period of not less than sixty months (five years) in a Nationalized Bank.
 - (f) Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum that they are going to adopt for the course.
 - (g) Institutions if starts the training programme without prior approval / permission of the competent authority / examining body regarding the curriculum that they have adopted and conduct of examinations for award of Diploma / Certificate the recognition of such institutions shall
 - (h) Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.

- Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a
- If the institution contravenes any of the above conditions or any of the 6 provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
