## REVISED RECOGNITION ORDER

WHEREAS, recognition was granted to Baba Vishwanath Mahavidyalaya, Plot Number- 87, 88, Street/Road- NA, Post Office- Muhamdalla, Tehsil/Taluka- Sadar, Town/City- Azamgarh, State- UP, District-Village/Town/City- Nibi, Azamgarh(UP), Pin Code- 276001 for D.El.Ed course with an intake of 100 students vide order No. NRC/NCTE/Recognition/D.El.Ed/2016/146821-7694 dt. 02.05.2016.

- AND WHEREAS, The matter was considered by NRC in its 253rd Meeting held from 30th may to 03rd June, 2016 (part-1) the Committee decided that recognition be granted to the institution for D.El.Ed course for one unit (50 students) under clause 7(16) of the NCTE Regulations, 2014 from the academic session 2016-2017. Accordingly, corrigendum vide order no. NRC/NCTE/corrigendum/2016/150089/106 dt. 08.06.2016 was issued to the institution.
- AND, WHEREAS, the institution filed writ petition no. 36149 of 2017 in the Hon'ble High Court of Allahabad and the Hon'ble High Court passed an order dated 16.08.2017. The matter was considered by NRC in its 280th Meeting held from 06th to 07th February, 2018 and the Committee decided that the direction given by the Hon'ble High Court at Allahabad are for the State Govt. and not for the NCTE. Hence, no action is required on the part of NCTE. Accordingly, a letter dt. 15.02.2018 was issued to the institution.
- AND, WHEREAS, A letter dt. 22.12.2017 received from Secretary, Exam Regulatory Authority, Allahabad. The matter was considered by NRC in its 282<sup>nd</sup> Meeting (part-1) held from 28th February to 01st March & 03rd March, 2018 and the Committee decided that recognition be granted to the institution for two units of D.El.Ed course in place of one unit granted earlier.
- NOW, THEREFORE, in exercise of the powers vested under Section14(3)(a)/15(3)(A) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Baba Vishwanath Mahavidyalaya, Plot Number- 87, 88, Street/Road-NA, Village/Town/City- Nibi, Post Office- Muhamdalla, Tehsil/Taluka- Sadar, Town/City- Azamgarh, State- UP, District-Azamgarh(UP), Pin Code- 276001 for D.El.Ed course with an annual intake of 100 seats (two basic units of 50 students each) from the academic session 2018-19 in place of one unit granted earlier vide order dated 08.06.2016.
