RECOGNITION ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Registrar, University of Allahabad, Plot No-University, Street/ Road-University Road, Vill.-Allahabad, Post Office- University of Allahabad, Teh/Taluk- Sadar Allahabad, Town/City- Allahabad, Dist- Allahabad (UP), State-UP, Pin-211002 had submitted an application (Code No. NRCAPP-3184) to the Northern Regional Committee of NCTE for grant of recognition for conducting M.P.Ed. course of two years duration with an annual intake of 40 seats (Forty only) on 18.12.2012 in the name of University of Allahabad, Plot No-University, Street/ Road-University Road, Vill-Allahabad, Post Office- University of Allahabad, Teh/Taluk- Sadar Allahabad, Town/City-Allahabad, Dist- Allahabad (UP), State-UP, Pin-211002.

- 2. AND, WHEREAS, NCTE Hqrs. vide letter No. F. 49-15/2013/NCTE/N&S/A73912 dated 12.09.2013 informed the Regional Committees that the Competent Authority in NCTE has decided as a one time measure to relax the procedural and infrastructural requirements for the Teacher Education Programmes, proposed to be set up, run by the Central Universities under clause 12 of NCTE (Recognition Norms & procedure) Regulations, 2009 for a maximum period of three years.
- 3. AND, WHEREAS, in view of the above relaxation, the application of the University was processed.
- 4. AND, WHEREAS, the Committee in its 231st meeting held on 21st to 24th January, 2015 decided to grant recognition to the University for M.P.Ed. course of two years duration with an annual intake of 40 (Forty only) students.
- NOW, THEREFORE, in exercise of the powers under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Department of Physical Education, University of Allahabad, Plot/Khasara No-Senate hall university, Plot No.- University, Street Number- University, Vill- University of Allahabad Post Office- University of Allahabad, Teh/Taluk- Sadar Allahabad, Town/City- Allahabad, Dist- Allahabad (UP), State-UP, Pin-211002 for conduction of M.P.Ed. course of 02 years (two years) duration with an annual intake of 40 seats (Forty only) from the academic session 2015-2016 under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
 - I. The infrastructural requirements shall be fulfilled within a period of 3 years, provided adequate infrastructural arrangement is made on lease/rental basis as per the stipulations of NCTE before approval, as per NCTE Hqrs. letter No. 49-15/2013/NCTE/N&S/A73912 dated 12.09.2013.
 - II. The University shall comply with various other norms and standards for the course prescribed in the NCTE Regulations, as amended from time to time.
 - III. The University shall ensure that the required number of academic staff for conducting the course is always in position.
- Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC etc. as applicable.
- 7. The University shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited.

- 8. The University shall maintain & update its Web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-
 - Copy of the Application Form
 - II. Land and Building Particulars
 - III. Staff Profile
 - IV. Recognition letter
 - V. Information for having fulfilled the norms & standards and other required conditions.
- 9. If the University contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993
- 10. Further, if the institution is not satisfied with the order, it may prefer an appeal under section 18 of the NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order.
