ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, the institution i.e. Shah Satnam Ji Girls College, Near Shah Mastana Ji Dham, Dera Sacha Sauda, Sirsa, Haryana has been recognized for B.Ed course by NRC vide order No. F.NRC/ NCTE/ F-3/HR-422/ 6321 dated 29th September 2006 with an annual intake of 100.
- 3. **AND WHEREAS,** the institution has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which requires additional facilities.
- 4. **AND WHEREAS,** it has been decided to permit the institution to have two basic units of 100 students subject to the institution fulfilling following conditions namely:-
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c)additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Shah Satnam Ji Girls College, Near Shah Mastana Ji Dham, Dera Sacha Sauda, Sirsa, Haryana for conducting B.Ed. programme of two years duration with an annual intake of 100 (one hundred only) for two basic unit of 100 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to Shah Satnam Ji College of Education, Shah Mastana Ji Dham, Dera Sacha Sauda, Sirsa, Haryana to conduct B.Ed. Course of One-year duration w.e.f. the session 2006-2007 with an annual intake of 100 (One HundredOnly) (One Unit), subject to appointment of staff as per 7(11) and 7(12) of NCTE Regulations dated 13.01.2006 and ratified by the University at the following address :-

- The institution shall ensure the fulfillment of the following :-4
 - The Institution shall maintain the teaching staff strength of 1+7 for the B.Ed. a.
 - The institution shall note that with regard to NET/SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006. D.
 - The institution shall adhere to all the other regulations and guidelines as framed by C. NCTE from time to time.
 - The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period de of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
 - That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form 8. of FDR in favour of the management/institution.
 - Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc. Ť.
 - The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating g. University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
