**WHEREAS**, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. **AND WHEREAS**, the institution K.V.M. College of Education, Khewat No. 173, Khata No. 204, Killa No. 28/21/2, 24/3, 25/3, 77/22/2/2/2/1, 78/3, 77/23/2, 63/6/2, 48/6/2, 7/2, 49/10/3, 78/3, 77/23/2, 63/6/2, 48/6/2, 7/2, 49/10/3, Maina Education Society (Regd.), At K.V.M. Public School, Ladhoh Road, Tehsil & Distt- Rohtak-124001, Haryana has been recognized by NRC vide its Order No. NRC/NCTE/F-77/HR-677/27837-43 dated 18.09.2007 for an additional intake of 100 seats in the existing B.Ed. course, thereby making the total annual intake of the institution to 200 seats.

3. **AND WHEREAS**, the institution has by affidavit consented to come under New Regulations and sought for four basic units in B.Ed., which requires additional facilities.

4. **AND WHEREAS**, it has been decided to permit the institution to have four basic units of 50 students each subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. **Now therefore**, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to K.V.M. College of Education, Khewat No. 173, Khata No. 204, Killa No. 28/21/2, 24/3, 25/3, 77/22/2/2/2/1, 78/3, 77/23/2, 63/6/2, 48/6/2, 7/2, 49/10/3, 78/3, 77/23/2, 63/6/2, 48/6/2, 7/2, 49/10/3, Maina Education Society (Regd.), At K.V.M. Public School, Ladhoh Road, Tehsil & Distt- Rohtak-124001, Haryana for conducting

B.Ed. programme of four years duration with an annual intake of 200 for four basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.


6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (a) Sanctioned programmes along with annual intake in the institution.
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section-17(1) of the NCTE Act.

ORDER

**K.V.M. College of Education, Ladhot Road, Rohtak (Haryana)** submitted an application to the Northern Regional Committee of National Council for Teacher Education for permission of **B.Ed Course** in terms of section **14 (1) of NCTE Act, 1993.**

2. The NRC at its 108<sup>th</sup> meeting held on 25-26 September 2006 at NRC, NCTE Jaipur considered application of the institution including in the agenda for the meeting and after careful examination of relevant documents, visiting team reports, Video Recording etc. found the institution fit for grant of recognition.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **K.V.M. College of Education, Ladhot Road, Rohtak (Haryana)** to conduct **B.Ed. Course** of One-year duration w.e.f. the session 2006-2007 with an annual intake of **100 (One Hundred Only) (One Unit)**, subject to appointment of staff as per 7(11) and 7(12) of NCTE Regulations dated 13.01.2006 and ratified by the University at the following address :-

**K.V.M. College of Education,  
Ladhot Road, Rohtak (Haryana)**

4. The institution shall ensure the fulfilment of the following :-

- The institution shall maintain the teaching staff strength of **1+7 for the B.Ed. Course.**
- The institution shall note that with regard to NET/SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
- Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- The institution shall regularly update its website.

ORDER

WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 **K. V. M. College of Education, Malna Education Society (Regd.), At K. V. M. - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.


